Test Test the effectiveness of the product in blocking the RFID signal	Observation An octopus card was placed inside the RFID Card Slider. Then the product with the octopus card was placed onto an octopus card reader which was capable to read octopus card at frequency at 13.56 MHz. The octopus card reader detected signal at 60mm without the use of RFID Card Slider. The octopus card reader did not detect any signal on both front side and opposite side with the use of RFID Card Slider even though the RFID Card Slider totally touched the reader. Conclusion: The product is capable to block RFID signal at	PASS
